### BRIEF OVERVIEW OF THE FORUM

Mozambique's economy has been recovering from the effects of the COVID-19 pandemic that hit the country and the world, as well as natural disasters and other adversities. GDP growth reached 4.4% in 2022 and 5.0% in 2023, resulting from the Government's concerted efforts to policy reforms and attracting investment to the country.

The Middle East market has been developing economic diversification away from exclusive dependence on oil & gas and other natural resources, with a focus on infrastructure, telecommunications and food security by investing in several countries, including those on the African continent.
