Located in Tissamaharama, the project aims to upgrade existing facilities and introduce new components to establish the park as a regional hub for film production and tourism. Implemented under the Design, Build, Finance, Operate, and Maintain (DBFOM) model, the selected investor will enter into a 30-year lease agreement, taking full responsibility for investment and operations. This initiative offers a strategic opportunity to strengthen Sri Lanka's creative economy and attract international media collaborations.

Project Overview

The selected investor will undertake the revitalization and expansion of existing the Mahinda Rajapaksa Ranmihithenna National Tele-Cinema Park under a 30-year lease agreement Design, Build, Finance, Operate, and Maintain (DBFOM) model with the Ministry of Buddhasasana, Religious and Cultural Affairs. Foreign entities are required to partner with a local firm through a joint venture or consortium. The project is expected to elevate Sri Lanka's position as a regional center for cinematic production and creative tourism. It will also contribute to long-term cultural and economic development through sustainable private sector engagement.
