1. Introduction

The Cargo Handling Corporation Ltd (CHCL), a state-owned company operating at the Port Louis Harbour, invites local and international qualified firms to submit an Expression of Interest (EOI) for the provision of Non-Destructive Testing (NDT) – Structural Integrity Inspection on Three (03) HHMC Ship-to-Shore Quay Cranes: QC01, QC02, and QC03 and Two (02) IMCC Cranes STS99 and STS100.

This EOI is being issued pursuant to the Public Procurement Act 2006 (PPA 2006), the Public Procurement Regulations 2008 (PPR 2008), and guidelines issued by the Public Procurement Office (PPO).

Qualified firms that express interest and meet the eligibility requirements will subsequently be invited to participate in a Restricted Bidding Process, where detailed Bidding Documents will be issued.

2. Objective of the Assignment

In alignment with manufacturer maintenance strategy recommendations, the objective is to undertake a comprehensive structural integrity assessment of terminal HHMC Quay Cranes QC01, QC02, and QC03, and IMCC Quay Cranes, STS99 and STS 100.

The inspection aims to:

- Identify and document structural defects (cracks, fatigue, corrosion, deformation).
- Ensure operational safety, reliability, and compliance with international standards.
- Detect early defects that may lead to catastrophic structural failure.

3. Scope of Services

3.1 Pre-Inspection Activities

- Review of engineering drawings, previous inspection reports, and maintenance records.
- Preparation of Risk Assessment and Method Statement (RAMS).
- Job Safety Analysis (JSA) and toolbox talk prior to mobilisation.
- Coordination with CHCL crane management for access and shutdown planning.

3.2 NDT Methods (as required)

- Visual Testing (VT)
- Ultrasonic Testing (UT) (thickness, flaw detection)
- Magnetic Particle Testing (MT)
- Eddy Current Testing (ET)
- Penetrant Testing (PT)
- Radiographic Testing (RT) (optional, if required)

3.3 Structural Areas to Be Inspected

(Refer to Annexed Drawings Provided in Bidding Stage)

- Slewing bearing assembly and frame support
- Boom structure and main girder connections
- Trolley rail and structural supports
- Tower column welds and base joints
- Luffing and hoisting mechanism structural components
- Access platforms, ladders, and railings
- Counterweight supports
- Headblock assemblies

3.4 Reporting Requirements

Detailed technical report covering:

- Test procedures and methods used
- Findings and defect mapping
- Photographic records
- Recommendations for repairs or continued use
- Standards referenced (ISO 9712, ASNT, AWS D1.1, etc.)

4. Deliverables

The service provider shall produce:

- Method Statement and Risk Assessment
- NDT inspection reports with findings
- Marked-up drawings showing defect locations
- Certification of NDT personnel (ISO 9712 or ASNT Level II/III)
- Final summary report and formal close-out session with CHCL

5. Personnel and Equipment Requirements

- Lead inspector must be ASNT Level II certified
- Technicians must hold ASNT/ISO Level I or II qualifications
- All NDT equipment must carry valid calibration certificates
- Service provider must supply access equipment (man lifts, scaffolding, rope access)
- Appropriate PPE must be provided by the bidder
