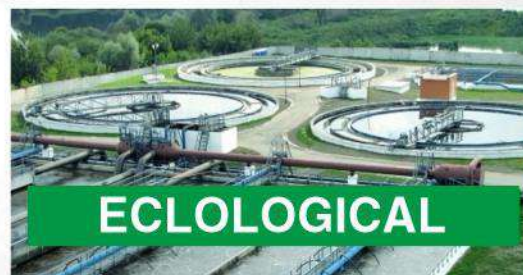
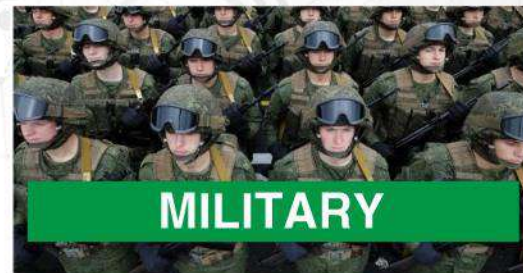
## THE CONCEPT

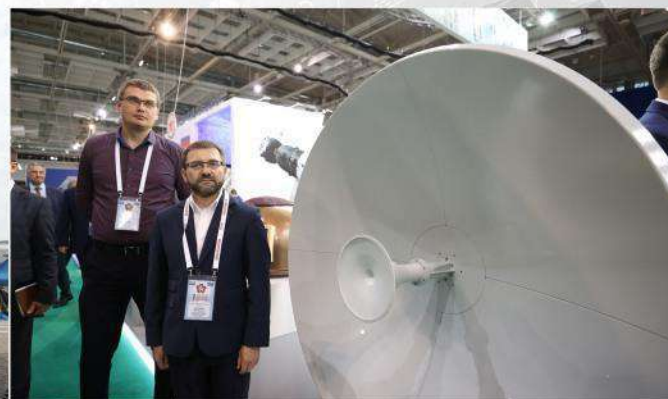
5.2. The main thematic sections of the exhibition are:

- information security «digital neighborhood belt», combating crimes in the field of high technology, cybersecurity;
- introduction and use of advanced achievements in the field of artificial intelligence in the practical activities of national security agencies;
- technical equipment for special forces units, special services, law enforcement agencies, armed forces;
- special machinery and equipment used in the implementation of the functions of national security agencies;
- technical systems for monitoring, prevention and liquidation of emergency situations, means of rescue in terms of the implementation of the functions of bodies and departments for emergency situations.





- equipment and components used in disaster medicine;
- tactical, social and other areas of medicine;
- technical means of border control;
- search and inspection equipment and technical means of customs control;
- anti-terrorist protection systems for critical, urban and other infrastructure facilities, prevention and detection of offenses and emergencies;
- nuclear safety systems;
- technical and software tools for ensuring the security of protected objects;
- modern technologies of education of employees of national security agencies;
- means and technologies for ensuring industrial, biological and environmental safety;
- space technologies in the practical activities of national security agencies.



## 6. EXHIBITION PROGRAM (EXPOSITION)

- 6.1. The exhibition program is developed on the basis of the thematic sections of the exhibition and is carry out in order to:
- assistance in the technical re-equipment of law enforcement and special services units, the Armed Forces, emergency agencies, whose activities are directly related to ensuring national security;
  - patriotic education, the formation of a positive public opinion (image) about the activities of law enforcement agencies, the Armed Forces, emergency agencies;
  - demonstration of the modern level of technical equipment of law enforcement agencies, armed forces, emergency agencies;
  - search for potential partners and contractors, expansion and establishment of business contacts in order to enter new markets;
  - informing the general public and citizens about the activities of national security agencies;
- 6.2. The exhibition program is formed taking into account the current and future needs of law enforcement and other government agencies in technical means, weapons and technologies.
- 6.3. In order to demonstrate the modern technical equipment of law enforcement agencies, special services, the Armed Forces, emergency agencies, the exhibition program includes demonstration performances of special and other units with the practical use of samples of weapons, special means and equipment, service dogs in conditions of practical use.



6.4. The participants of the exhibition are enterprises and organizations of the Republic of Belarus, of the member states of the CSTO, SCO, BRICS, the League of Arab States, ASEAN, CIS, as well as other foreign states that are workers and manufacturers of samples of weapons, military and special equipment, security systems, software products and applications, advanced technologies and solutions for the protection of information, objects and territories as well as achievements in the field of artificial intelligence.

6.5. The target audience of the exhibition is:

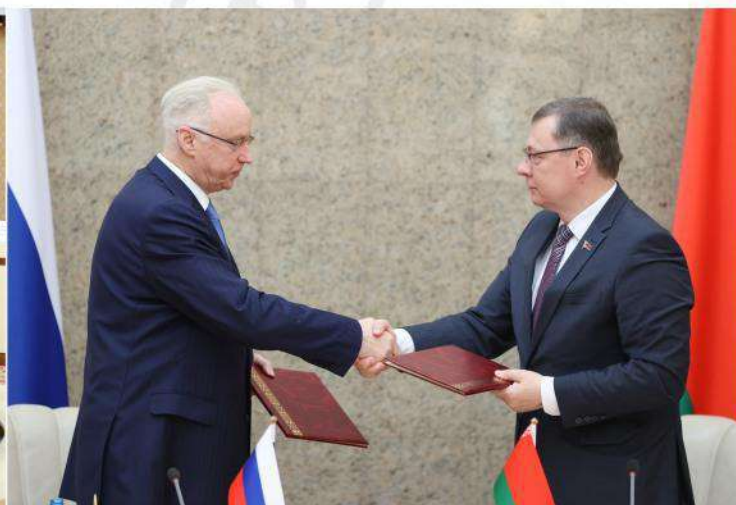
- administration and representatives of state bodies and other organizations of the national security system of the Republic of Belarus;
