BLUE ECONOMY

The Zanzibar Blue Economy is a strategic pillar of the archipelago's "Vision 2050," positioning the ocean as the primary engine for inclusive, sustainable, and resilient growth. Under the Zanzibar Development Plan (ZADEP) 2021–2026, the government has shifted from a traditional land-based focus to a sea-based economic model that integrates high-potential sectors such as sustainable tourism (which accounts for nearly 60% of GDP), modernized fisheries, and seaweed farming, the latter of which provides livelihoods for over 25,000 workers, 80% of whom are women. Beyond resource extraction, the strategy emphasizes value-chain development in aquaculture, maritime trade through port expansion, and the exploration of offshore energy, all while prioritizing ocean governance to combat illegal fishing and climate-induced habitat degradation. By 2026, Zanzibar aims to solidify its status as the leading hub for blue economy activities in the Western Indian Ocean, balancing aggressive infrastructure investment with a commitment to marine biodiversity and the socio-economic empowerment of its coastal communities.

PROJECT DESCRIPTION

BACKGROUND AND JUSTIFICATION

Zanzibar is strategically located within the Western Indian Ocean and possesses extensive marine resources suitable for large-scale aquaculture development. While capture fisheries have traditionally supported livelihoods and food security, increasing pressure on wild fish stocks due to population growth, climate change, and overfishing has reduced sustainability and income potential. At the same time, global demand for high-quality, sustainably farmed marine fish is rising, presenting an opportunity for Zanzibar to diversify its fisheries sector through offshore mariculture. The Marine Fish Cage Farming Project proposes the establishment of technologically advanced offshore cage systems to increase fish production, enhance food security, and support the Blue Economy.

Zanzibar currently relies heavily on imported fish and faces fluctuating domestic supply due to seasonal variability and declining nearshore catches. Developing large-scale offshore aquaculture will stabilize fish supply, reduce import dependency, and improve food security. Furthermore, without deliberate investment in modern Mariculture systems, Zanzibar risks missing out on regional and international market opportunities for premium farmed fish products.

The project is needed to address structural constraints in Zanzibar's fisheries sector and to respond to growing demand for sustainable marine protein. Wild capture fisheries alone can no longer meet domestic consumption needs or support export growth without risking resource depletion.

BENEFICIARIES AND STAKEHOLDERS

The beneficiaries of the project are coastal communities and fishers, youth and women employed in aquaculture and value addition, fish processors, traders, and exporters, consumers through improved availability of fish, government through increased revenues and investment.

Key stakeholders include Ministry of Blue Economy and Fisheries, Department of Fisheries and Aquaculture Development, Zanzibar Fishing Company (ZAFICO), Zanzibar Investment Promotion Authority (ZIPA), Private aquaculture investors and operators, Zanzibar Fisheries and Marine Resources Research Institute (ZAFIRI), universities, and Development partners.

KEY PROJECT OBJECTIVES

Main Objective

To establish a sustainable, large-scale offshore marine fish cage farming industry that enhances food security, creates employment, and positions Zanzibar as a regional hub for mariculture.

Specific Objectives

- a) Establish 320 offshore production cages in Unguja and Pemba waters
- b) Produce 30,000–40,000 tons of marine fish annually within five years
- c) Reduce dependence on imported fish products
- d) Create direct and indirect employment across the aquaculture value chain
- e) Promote environmentally responsible aquaculture practices
- f) Attract private investment and modern aquaculture technology

EXPECTED RESULTS (OUTCOME)

The expected results from this project include increased and stable supply of high-quality marine fish, improved food security and nutrition, creation of new jobs in production, processing, and logistics. Others outcomes are growth of aquaculture-related enterprises, reduced pressure on wild capture fisheries, and strengthened institutional capacity for mariculture management.

PROJECT COMPONENTS

The project is expected to cover the following components:

a) **Physical Facilities**

This component includes offshore HDPE fish cages and mooring systems, offshore service platforms and operational bases, as well as onshore processing, cold storage, and logistics facilities.

b) **Equipment and Tools**

This component includes automated feeding systems, environmental monitoring and sensor technologies, harvesting and live fish transport equipment, and predator exclusion and protection systems

c) **Support and Enabling Services**

This component includes environmental and social monitoring systems, capacity building and technical training, community engagement and benefit-sharing mechanisms Market development and certification support

PROJECT DESCRIPTION

BACKGROUND AND JUSTIFICATION

Zanzibar's economy and livelihoods are deeply connected to the marine environment, with fishing, tourism, and sea transport supporting a large share of the population. Despite the strategic importance of the maritime sector, Zanzibar lacks modern boat-building and maintenance facilities. The majority of vessels in use are traditional wooden boats that are costly to maintain, limited in performance, and increasingly unsustainable from an environmental perspective. The absence of local manufacturing and maintenance capacity has become a critical constraint. The establishment of a Commercial Boat Building and Maintenance Factory in Zanzibar is a strategic necessity driven by structural gaps in the maritime sector. Most traditional boats cannot safely travel offshore; limiting the potential of Zanzibar's fishing.

Currently, Zanzibar depends heavily on imported modern vessels from mainland Tanzania, Kenya, the United Arab Emirates, and Europe. These imports are costly, difficult to customize, and often unsuitable for local operating conditions. Operators in both fisheries and tourism frequently face long delays when sourcing new boats or repairing existing ones, as many repairs require specialized services available only outside Zanzibar. The fishing industry needs modern vessels to access deeper fishing grounds and increase productivity. Economically, the opportunity for growth is substantial. The tourism sector continues to expand rapidly, with increasing demand for watercraft used in diving, snorkeling, dolphin tours, sunset cruises, and island transfers. The fishing industry needs modern vessels to access deeper fishing grounds and increase productivity.

BENEFICIARIES AND STAKEHOLDERS

Project beneficiaries include fishers and fishing cooperatives, tourism operators and marine transport providers, Government agencies requiring marine vessels, skilled and semi-skilled workers in marine engineering and manufacturing as well as local suppliers and service providers.

Key Stakeholders of the project are Ministry of Blue Economy and Fisheries, Zanzibar Maritime Authority (ZMA), Zanzibar Investment Promotion Authority (ZIPA), Private investors and boat operators, as well as Training institutions and technical partners.

KEY PROJECT OBJECTIVES

Main Objective

To establish a modern commercial boat building and maintenance facility that enhances local production capacity, improves maritime safety, and supports sustainable growth of Zanzibar's Blue Economy.

Specific Objectives

- a) Establish a fully equipped boat-building and maintenance factory within three years
- b) Increase availability of locally built, durable, and affordable marine vessels
- c) Reduce vessel repair and maintenance turnaround time by at least 40%.
- d) Promote skills development and technology transfer in marine engineering
- e) Reduce reliance on imported vessels and external repair services.

EXPECTED RESULTS (OUTCOME)

The expected project outcomes are increased supply of high-quality vessels built to international standards, reduced operational costs and downtime for marine operators, and creation of skilled employment and transfer of modern marine technologies. Other outcomes are improved maritime safety across fisheries, tourism, and transport sectors as well as growth of a competitive local marine manufacturing industry.

PROJECT COMPONENTS

The project is expected to cover the following components:

a) **Physical Facilities**

This component covers boat construction workshops and assembly halls, dry dock or hoist system for vessel maintenance, and administrative offices and storage facilities

b) **Equipment and Tools**

This component covers welding and cutting machinery, composite molding and fabrication systems, engine installation and electrical outfitting equipment, as well as maintenance and repair tools.

c) **Support and Enabling Services**

This component covers naval architecture and design services, skills training and apprenticeship programs, quality assurance and safety compliance systems, and after-sales maintenance and service contracts

PROJECT DESCRIPTION

BACKGROUND AND JUSTIFICATION

Zanzibar is strategically located within the Western Indian Ocean, one of the world's most productive tuna and pelagic fisheries regions. Despite the abundance of offshore fish resources, Zanzibar's fishing industry remains largely artisanal, constrained to near shore waters and unable to exploit deep-sea resources within its Exclusive Economic Zone. The proposed project aims to develop a modern, sustainable deep-sea fishing industry to increase offshore production, enhance exports, generate employment, and strengthen Zanzibar's Blue Economy.

The proposed Development of a Sustainable Deep-Sea Fishing Industry in Zanzibar is necessary to address structural limitations in the fisheries sector that currently prevent the country from fully benefiting from its offshore marine resources. Although Zanzibar is endowed with a large Exclusive Economic Zone located in one of the most productive tuna and pelagic fishing areas in the Western Indian Ocean, these resources remain largely untapped by domestic operators due to technical, infrastructural, and institutional constraints. These constraints include: Limited access to offshore fisheries due to absence of modern vessels, High dependence on foreign industrial fleets with minimal local economic benefit, inadequate landing, cold-chain, and processing infrastructure, High post-harvest losses and low value addition, skills gaps in deep-sea fishing operations and marine engineering and Weak monitoring and control systems contributing to Illegal, Unreported and Unregulated (IUU) fishing.

BENEFICIARIES AND STAKEHOLDERS

Beneficiaries:

Local fishers and fishing cooperatives, Fish processors and exporters, Women and youth engaged in processing and value addition, Coastal communities, and Government through increased revenues

Stakeholders:

Ministry of Blue Economy and Fisheries, Department of Fisheries and Marine Resources, Zanzibar Investment Promotion Authority (ZIPA), Private investors and operators, and Development partners.
Training institutions and technical partners.

KEY PROJECT OBJECTIVES

Main Objective

To establish a sustainable, profitable, and well-regulated deep-sea fishing industry that fully utilizes Zanzibar's offshore marine resources.

Specific Objectives

- a) Introduce 10–15 modern deep-sea fishing vessels within five years
- b) Upgrade priority landing sites with cold-chain facilities by year three
- c) Establish fish processing plants for domestic and export markets
- d) Strengthen governance systems to reduce IUU fishing
- e) Build technical and institutional capacity across the fisheries value chain
- f) Develop export market linkages and value-addition enterprises

EXPECTED RESULTS (OUTCOME)

BACKGROUND AND JUSTIFICATION

The country needs to have a reliable and affordable gas supply that can be used for different purposes including electricity generation, household uses, institutional uses, commercial uses and automotive engines (cars, motorcycles etc.), currently Zanzibar is facing lack of those infrastructures to support Gas business. With the rising demand for gas in Zanzibar that can be used for different purposes, the issue of having a reliable and affordable supply is of the essence. Zanzibar facing challenges of consumption of traditional energy sources such as firewood, charcoal, kerosene etc.

According to Census 2022 Demographic Social and Economic Statistics depict the consumption of traditional energy sources which is, 46.9% Firewood, 28.9% charcoal, 1.6% Kerosene, 2.3% others to compare with 12.8% Gas. These challenges call for immediate measures for ensuring the Islands get reliable, cost-effective, cleaner and environmentally friendly energy sources such as Natural Gas. Success of such efforts will enable Zanzibar to be in line with various global cleaner and green energy protocols to mitigate climate changes through decarbonisation.

BACKGROUND AND JUSTIFICATION

Marine resources, especially fisheries, which support income, employment, and food security. However, overfishing, population growth, climate change, and limited livelihood alternatives have led to declining fish stocks and unstable incomes. In response, the Revolutionary Government of Zanzibar established the Ministry of Blue Economy and Fisheries to promote sustainable marine resource use, prioritizing aquaculture development, including fish cage farming.

Fish cage farming offers a sustainable alternative to capture fisheries by increasing fish production without further exploiting natural stocks. It is well suited to Zanzibar's marine environment and has strong potential to produce species such as milkfish and tilapia for local markets. The sector also presents significant opportunities for youth and women employment, income diversification, and private sector investment. Despite its potential, cage aquaculture in Zanzibar remains underdeveloped due to limited technical skills, inadequate access to quality fingerlings and feed, and weak market linkages. At the same time, demand for fish from households, hotels, and the tourism sector continues to grow. Therefore, investing in fish cage farming is justified as it will increase fish production, improve household incomes, create employment, strengthen food security, and contribute to sustainable Blue Economy development in Zanzibar while reducing pressure on wild fisheries.

PROJECT DESCRIPTION

BACKGROUND AND JUSTIFICATION

Zanzibar's economy and livelihoods are deeply connected to the marine environment, with fishing, tourism, and sea transport supporting a large share of the population. Despite the strategic importance of the maritime sector, Zanzibar lacks modern boat-building and maintenance facilities. The majority of vessels in use are traditional wooden boats that are costly to maintain, limited in performance, and increasingly unsustainable from an environmental perspective. The absence of local manufacturing and maintenance capacity has become a critical constraint. The establishment of a Commercial Boat Building and Maintenance Factory in Zanzibar is a strategic necessity driven by structural gaps in the maritime sector. Most traditional boats cannot safely travel offshore; limiting the potential of Zanzibar's fishing.

Currently, Zanzibar depends heavily on imported modern vessels from mainland Tanzania, Kenya, the United Arab Emirates, and Europe. These imports are costly, difficult to customize, and often unsuitable for local operating conditions. Operators in both fisheries and tourism frequently face long delays when sourcing new boats or repairing existing ones, as many repairs require specialized services available only outside Zanzibar. The fishing industry needs modern vessels to access deeper fishing grounds and increase productivity. Economically, the opportunity for growth is substantial. The tourism sector continues to expand rapidly, with increasing demand for watercraft used in diving, snorkeling, dolphin tours, sunset cruises, and island transfers. The fishing industry needs modern vessels to access deeper fishing grounds and increase productivity.

BENEFICIARIES AND STAKEHOLDERS

Project beneficiaries include fishers and fishing cooperatives, tourism operators and marine transport providers, Government agencies requiring marine vessels, skilled and semi-skilled workers in marine engineering and manufacturing as well as local suppliers and service providers.

Key Stakeholders of the project are Ministry of Blue Economy and Fisheries, Zanzibar Maritime Authority (ZMA), Zanzibar Investment Promotion Authority (ZIPA), Private investors and boat operators, as well as Training institutions and technical partners.

PROJECT DESCRIPTION

BACKGROUND AND JUSTIFICATION

Anchovy (dagaa) is one of Zanzibar's most abundant and economically important small pelagic fish species, providing livelihoods to coastal communities in Unguja and Pemba. However, traditional sun-drying practices, inadequate handling facilities, and limited processing technology have resulted in post-harvest losses, low product quality, reduced market competitiveness, and limited income for fishers especially women and youth who dominate post-harvest activities.

To address these challenges, the Government has constructed modern infrastructure at Kama, Unguja, to support a state-of-the-art dry anchovy processing and value addition facility. The project integrates drying racks, solar dryers, washing and steaming units, loading/offloading bays, weighing systems, a fish meal plant with machinery, warehouses, factory buildings, a chemical storage facility, business center, and rental accommodations. A private partner is invited to install and procure advanced processing machinery to operationalize value-addition processes.

BENEFICIARIES AND STAKEHOLDERS

Direct project beneficiaries include small-scale fishers (anchovy fishers), women fish processors and traders, youth engaged in fisheries and value addition activities, workers employed at the processing plant, and private investors and business operators.

Stakeholders are local communities in Kama and surrounding areas (Unguja), transporters and suppliers, exporters and seafood retailers, consumers (local and international), and the government.

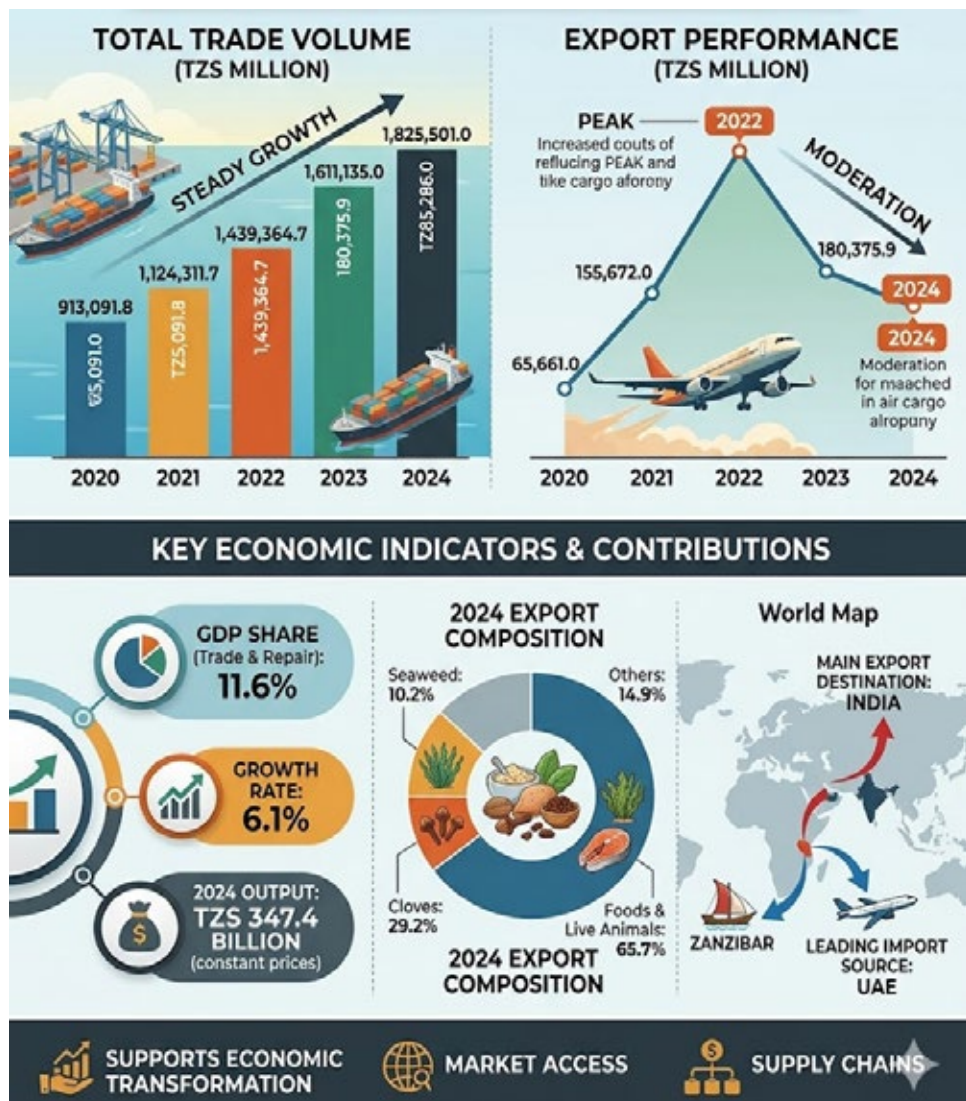

The Zanzibar Bureau of Standards (ZBS) Test House is a strategic investment to strengthen Zanzibar's quality infrastructure and regulatory capacity by establishing a modern laboratory facility at Dunga, Unguja Island. The center will house specialized laboratories for electrical testing, food chemistry, microbiology, textiles, packaging, chemical analysis, metrology, and construction materials testing, addressing the current gap in testing and certification services. Limited laboratory capacity has constrained industrial growth, regulatory enforcement, and consumer protection, while local industries face challenges meeting domestic and international quality standards. The project aligns with ZADEP priorities on industrial transformation, tourism diversification, and economic competitiveness. By providing world-class testing services, the facility will protect consumers, combat substandard and counterfeit goods, and support local manufacturers in accessing regional and international markets. Key beneficiaries include government agencies, local industries, consumers, and exporters.

The Utilities Meter Testing Laboratory project is positioned within the water and electricity sectors, where accurate metering is essential for fair billing, consumer protection, and effective regulation, yet Zanzibar faces limited local capacity for meter testing and calibration. The project aims to establish a modern, purpose-built laboratory at Kisakasaka for testing, calibration, and verification of water and electricity meters. Currently, the use of inaccurate or non-compliant meters undermines consumer confidence, utility revenues, and regulatory enforcement. The project will address gaps in metrological infrastructure and reduce dependence on external testing facilities. It will strengthen enforcement of national and international metrological standards. The investment aligns with sector strategic plans and national development priorities, including ZADEP. Consumers will benefit through protection from faulty meters and fair billing. Regulatory and utility institutions such as ZAWEMA, ZAWA, and ZECO will gain improved technical and operational capacity.

BACKGROUND AND JUSTIFICATION

Abeid Amani Karume International Airport (AAKIA) is a critical gateway for Zanzibar's tourism and commercial activities and a key driver of the islands' competitiveness in the East African aviation market. Construction of a new passenger terminal building, together with its associated facilities, with a design capacity of over 3 million passengers per annum, is essential to meet Zanzibar's future air travel demand.

The combined capacity of the existing Terminal 2 and Terminal 3, including the recently constructed (expanded) Terminal 2, is approximately 2.8 million passengers per year, which will be insufficient to accommodate the projected growth in passenger traffic. In 2025, the airport handled approximately 2.4 million passengers, while passenger traffic has grown at an average rate of over 10% annually for the past four years. The current terminal infrastructure will reach saturation in the near future and will not adequately support Zanzibar's long-term tourism, trade and aviation development needs. Consequently, the development of a new terminal is a strategic priority to ensure capacity adequacy, service quality and operational efficiency in line with future demands.

BENEFICIARIES AND STAKEHOLDERS

Project beneficiaries include AAKIA passengers, handlers, business sector and other airport users. 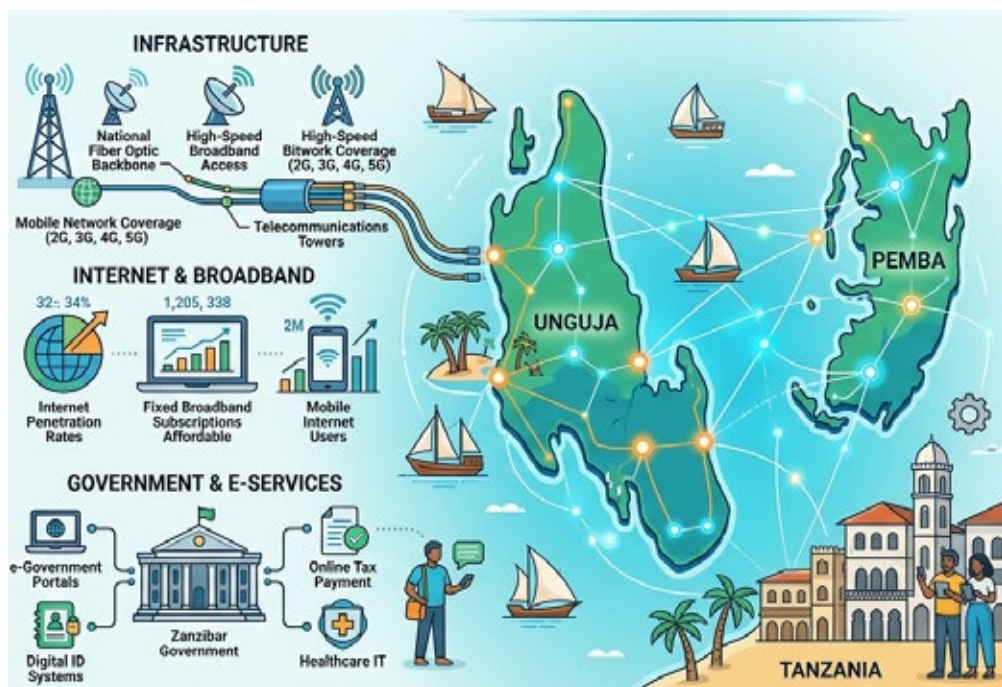

These efforts are complemented by a shift toward a startup-friendly ecosystem and "Silicon Zanzibar" initiatives, focusing on integrating emerging technologies like AI and FinTech into the Blue Economy to drive economic diversification and universal digital inclusion.

Zanzibar is among the country with most youthful societies in the region with an estimate of more than 62% of Zanzibaris are under the age of 35. This demographic strength provides Zanzibar with an opportunity to harness the creativity, resilience, and innovative power of our young people as catalysts of economic transformation, social progress, and global competitiveness.

Youth unemployment and underemployment remain among the most critical development challenges facing Zanzibar, with direct implications for economic growth, social cohesion, and long-term national productivity. The findings from the Integrated Labour Force Survey (ILFS, 2024) indicates that the unemployment rate of youth in Zanzibar has grown by 6.6 percentage points, from 11.1% in 2020/21 (Men: 7.9%, Women: 15.9%) to 17.7% in 2024 (Men: 10.3%, Women: 26.8%).

As we enter the 2025 - 2030 planning cycle, the Revolutionary Government of Zanzibar remains fully committed to accelerating youth empowerment as a national development priority through creating an enabling environment in which every Zanzibarian, particularly youth, is equipped, motivated, and empowered to contribute meaningfully to Zanzibar Economy. On the other hand, the Government has been able to increase tax collection and improve the quality of services provided to Zanzibari such as education, health and infrastructure, which has led to the strengthening of the workforce for the Zanzibar economy.

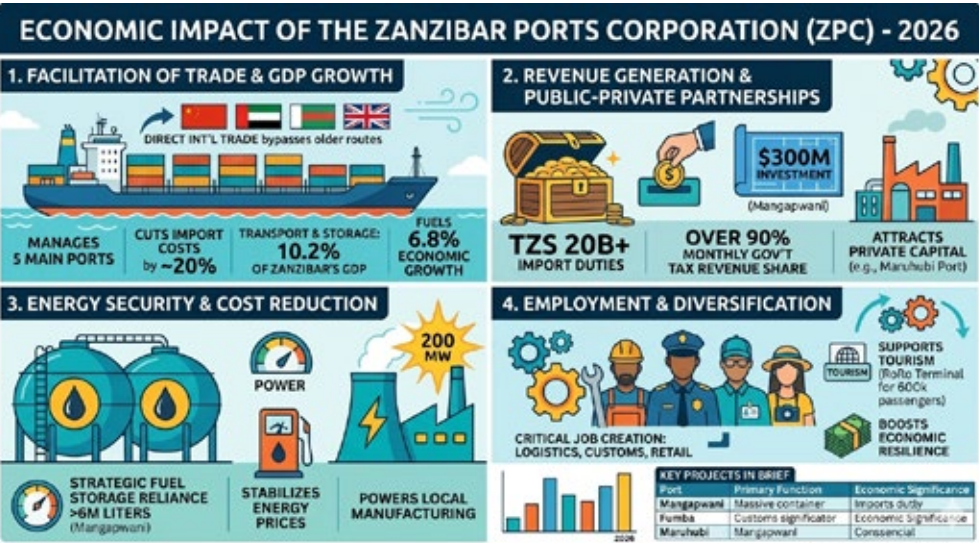

BACKGROUND AND JUSTIFICATION

Wete is the administrative, commercial, and economic centre of the North Pemba Region. Despite its strategic position along the Pemba Channel and proximity to mainland Tanzania and regional maritime routes, Wete lacks a modern port facility capable of safely and efficiently handling cargo and passenger traffic. Currently, maritime transport serving Pemba relies heavily on inadequate landing facilities and alternative ports such as Mkoani and Unguja. This results in high transport costs, operational inefficiencies, safety risks, and constrained economic growth. The Government of Zanzibar commissioned a feasibility study to assess the technical, economic, and financial viability of developing a modern port at Wete. The study confirmed that modernization of Wete Port is feasible and economically justified, with long-term benefits outweighing the investment costs.

Economic Development: Improved port infrastructure will stimulate trade, reduce transport costs, and support local industries.

BACKGROUND AND JUSTIFICATION

The Economy of Zanzibar grow rapidly, which lead to increase of high demand of electricity which attributed by the growth of Tourism sector includes many coastal Hotels. The electricity demand are expecting to increase in near future due to expansion of Karume International Airport, Construction of new City at Mazizini, Mweni, Fumba, construction of new port at Mpigaduri and shopping mall at Malindi, construction of new port at Mangapwani, construction of many five stars hotels between Northern and southern of the Unguja Island. Because of that, ZECO need to strengthen and expand its infrastructures in order to provide reliable power supply for the whole of Zanzibar Islands to support the economy of Zanzibar and social wellbeing of its citizen.

Considering the existing power supply to the Unguja island, there is need to develop and implement another high voltage Transmission line with Substation cable from Kilombero to Mangapwani operated at 132kV, From Matemwe to Nungwi, and Substation at Nungwi, Mangapwani, Fumba and extension and refurbishment of old 132kV substation in order to increase power supply capacity and meet the increasing demand. Hence, Currently TANESCO with engagement of ZECO decided to initiate the Project of increasing power supply to Zanzibar to meet the increasing demand. The following proposed scope of work to evacuate the Bulk power:

Lot 1

- 132 kV transmission line from Kilombero to Mangapwani.
- Construction of Substation 132/33Kv Substation at Mangapwani

Lot 2

- Construction of 132/33kV Substation at Fumba

Lot 3

- 132kV Transmission line from Matemwe to Nungwi
- Construction of 132/33Kv at Nungwi

Lot 4

- Extension of existing switchyard and refurbishment of existing of old 132Kv Substation

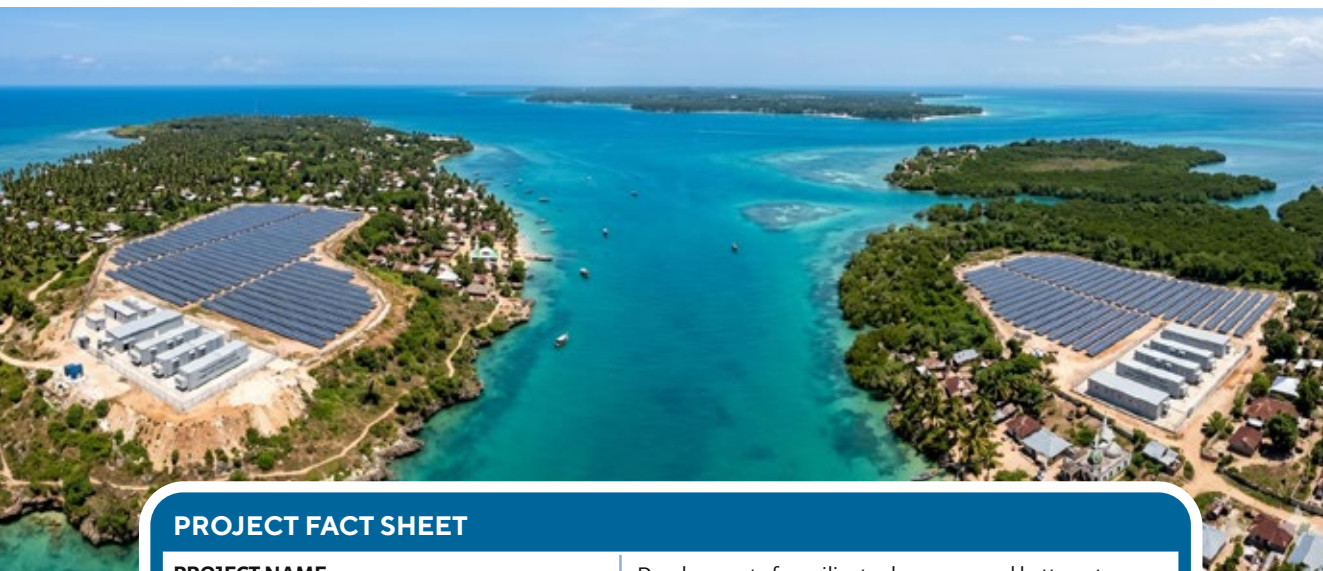

PROJECT DESCRIPTION

BACKGROUND AND JUSTIFICATION

Tumbatu Island and Uzi Island, part of the Zanzibar Archipelago in Tanzania, face significant energy challenges due to an unreliable electrical grid and increasing demand for energy. The existing grid infrastructure often fails to meet the daytime and nighttime electricity needs of the communities, leading to frequent blackouts and reduced economic growth. To address these challenges, this project proposes the implementation of a Solar Energy system with 4MWh battery storage system on Tumbatu Island and a Solar Energy system with 3 MWh battery storage system on Uzi Island. This initiative aims to improve the reliability of electricity supply, thus enhancing the functionality of the existing grid and fostering sustainable development. Due to the logistical and technical complexities associated with supplying power to Tumbatu Island and Uzi Island via submarine cables and overhead lines respectively, the energy demands of these islands remain inadequately met. The existing grid often experiences disruptions, resulting in frequent outages and limited-service availability. This situation hinders local economic development, increases reliance on expensive fuel imports, and diminishes the overall quality of life for residents. To mitigate these issues, this proposal advocates for the adoption of renewable energy solutions comprising solar energy systems and battery storage. The aim is to establish a reliable and sustainable energy supply for both islands without the complications that physical power connectivity entails.

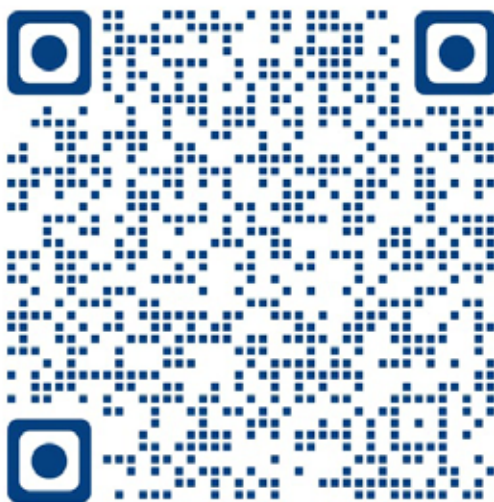

INCENTIVES

The Zanzibar Public-Private Partnership (PPP) framework, governed by the Zanzibar Investment Act No. 10 of 2023 and the PPP Act, provides a competitive incentive structure designed to attract private capital for public infrastructure and service delivery. These incentives are categorized into fiscal and non-fiscal benefits aimed at reducing project risk and enhancing long-term profitability.



INVESTMENT INCENTIVES AND APPLICATION PROCEDURE

This section elaborates the investment incentives available for investors. The incentives for strategic projects are different from those of PPP projects. In addition, the section provides procedure for applying incentives for both strategic and PPP project opportunities.

INCENTIVES FOR STRATEGIC PROJECTS

These incentives are eligible for investors who will implement the projects privately without collaborating with the Government. The incentives are divided into three categories, which are incentives during implementation period, during operation phase and incentives for manufacturing sector. These incentives are described as follows:

Incentives During Project Implementation Period

During project implementation period, the investor who has been granted Strategic Investment status may be granted the following incentives:

- (a) Upon application, One Hundred percent of duties and taxes on importation and local purchases of construction goods or pre-operational goods and materials and any other goods of capital nature;
- (b) One Hundred percent exemption of income Tax on interest for capital borrowed from foreign banks;
- (c) Maximum of five years grace period on payment of land lease starting from the date of the land lease;
- (d) One Hundred percent of foreign ownership is allowed;
- (e) Engagement of foreign contractors is allowed, provided that all construction machineries and equipment shall be under temporary importation schemes;
- (f) Five years grace period on payment of marina lease starting from the date of the land lease; and
- (g) One Hundred percent exemption of Value Added Tax for construction services for Pemba and small islands in Zanzibar.

Incentives During Project Operation Phase

The Investor who has been granted Strategic Investment status may, where appropriate, be granted the following incentives during operation of the Approved investment:

- (a) by application, one hundred percent exemption of corporate income tax for the first five years and fifty percent exemption for the next ten years;
- (b) One Hundred percent allowance of branch profit tax on repatriated profit;
- (c) One Hundred percent exemption on accelerated depreciation of plant and machinery for five years;
- (d) One Hundred percent exemption on research and development expenditure for five years; and
- (e) One Hundred percent retention of all profit after paying all relevant taxes.

Incentives for Strategic Investment in the Manufacturing Sector

Without prejudice to the incentives elaborated in item 5.1.2 and 5.1.3, the investor who has been granted status of strategic investment in the manufacturing sector may further be granted the following incentives:

- (a) One hundred percent exemption from payment of any tax on all goods produced for exports;
- (b) One hundred percent exemptions from paying of levies, fees or any other charges for raw materials and industrial inputs procured from Tanzania Mainland;
- (c) One hundred percent exemption from payment of import duty, excise duty and VAT on importation of

- heavy machines and equipment;
- (d) One hundred percent exemption from payment of VAT on local purchases of heavy machineries or equipment required during production phase;
- (e) One hundred percent exemption from payment of import duty, VAT and other similar taxes on raw materials and packaging materials during project operations;
- (f) import duty remission on importation of raw materials and industrial input provided under the East African Community Customs laws subject to application by the United Republic of Tanzania; and
- (g) One hundred percent exemption of income Tax on interest on registered borrowed capital for the period often years from the year of operation.

Incentives for PPP Projects

The incentives for PPP are subject to negotiations between the government and investors. They may fall under categories tax incentives during project construction, operation and exit. Specific incentives in each of these categories are as follows:

Tax incentives during Construction Phase

The Private Partner is exempted from payment of the following during the Construction Phase:

- (a) 100% exemption of duties and taxes on importation and local purchases of construction goods and materials of capital nature.
- (b) 100% exemption of income tax on interest on capital borrowed from foreign banks.
- (c) 100 % exemption from all duties and taxes on machinery, equipment, spares, heavy duty vehicles, administration vehicles, building and construction materials and any other goods of capital nature.
- (d) 100 % exemption of Value Added Tax for construction services.

Tax incentives During operation

The private partner is exempted from payment of the following taxes during operation phase of the project:

- (a) 100 % exemption of income tax on interest on capital borrowed from foreign banks.
- (b) 100 % exemption of duties and taxes on importation and local purchases of machinery, equipment, heavy duty vehicles, administration vehicles, building and construction materials, spares and any other goods of capital nature to be used for purposes of administration, operation and maintenance of the Project Facilities.
- (c) 100 % exemption on research and development expenditures.
- (d) 100 % exemption on accelerated depreciation of plant and machinery; and
- (e) Withholding tax (WHT) on dividends and interest payments.
- (f) Subject to the agreed commercial terms under the Agreement, the Private Partner is 100 % exempted from payment of Corporate Income tax during the Project Period under the Agreement.

Tax incentives on exit

When applicable, the private partner and on exit the market in accordance with international practices for any proposed sale of the private partners' rights to the project by an Independent third party, as the case may be (an "exit sale transferee"), the Government shall exempt such proceed from sale on all of the income tax and any other taxes or rent in connection with such proceeds as part of part of the exit sale.
